Dear parents and guardians,

The Regional School Unit No. 5 MLTI Device Protection Plan is designed to provide students and families coverage in the event that non-warranty damage occurs to the Maine Learning Technology Initiative (MLTI) device.

Although coverage is not mandatory to take the device home, if you opt out of the plan, you will be responsible for the full cost of the device if it is lost, damaged, etc. Scholarships are available to families and students who receive free or reduced meals. Please contact the main office at your son's or daughter's school for more information about scholarships.

We ask that you take a moment to talk with your son or daughter about responsible use and care of the MLTI device. The device will most likely follow your child through their tenure in RSU5, so careful use and routine maintenance are important keys to long system life. Additionally, a parent or guardian must attend an informational meeting at the start of the school year. Meetings are offered each fall and parents need to only attend once.
