Mr. Im welcomed all to the meeting and explained the following:

ARTICLE 13:

Ms. Ritcheson moved, Ms. Parker seconded to see what sum the Regional School Unit will raise and appropriate for the annual payments on debt service previously approved by the Regional School Unit voters for non-state-funded school construction projects or non-state-funded portions of school construction projects in addition to the funds appropriated as the local share of the Regional School Unit's contribution to the total cost of funding public education from kindergarten to grade 12.

School Board Recommends \$372,490

ARTICLE 14:

Ms. Ritcheson moved, Ms. Parker seconded to see what sum the Regional School Unit will raise and appropriate in additional local dollars in support of the school nutrition program.

School Board Recommends \$373.429

ARTICLE 15:

Ms. Ritcheson moved, Ms. Parker seconded to see what sum the Regional School Unit will raise and appropriate in additional local funds (Recommend \$8,518,194), which allow this budget to exceed the State's Essential Programs and Services allocation model by (Recommend \$7,615,841.15 as required to fund the budget recommended by the School Board.

The School Board Recommends \$8,518,194 for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services funding model by \$7,615,841.15. The State's Essential Program and Services funding formula is a minimum model to support education in grades K-12. RSU No. 5 provides additional funds to support lower student/teacher ratios and additional co-curricular activities in addition to complete educational programs for all our students.

Moderator suggests that amounts recommended may be increased to adjust for increase to Article 6.

Moderator explains that this would bring the new amount exceeding the State's Essential Program and Services funding formula to \$7,689,209.15.

Mr. Ritcheson moved the amounts of additional local funds stated. Ms. Parker second.

ARTICLE 16:

Ms. Ritcheson moved, Ms. Parker seconded to see what sum the Regional School Unit will authorize the School Board to expend for the fiscal year beginning July 1, 2017 and ending June 30, 2018 from the Regional School Unit's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.

School Board Recommends \$32,134,317

The motion was made by Ms. Ritcheson to adopt Article 16 in the amount of \$32,207,685 to adjust for increase to Article 6, Ms. Parker seconded.

Ms. Ritcheson moved, Ms. Parker seconded that in addition to amounts approved in the preceding questions, shall the School Board be authorized to expend such other sums as may be received from federal or state grants or programs or other sources during the fiscal year for school purposes, provided that such grants, programs or other sources do not require the expenditure of other funds not previously appropriated?

Ms. Ritcheson moved, Ms. Parker seconded that the Regional School Unit appropriate \$237,229 for adult education with authorization to expend any additional, incidental, or miscellaneous receipts in the interest and for the well-being of the adult education program and raise \$103,000 as the local share?

Ms. Ritcheson moved, Ms. Parker seconded that the regional career and technical education operating budget as approved by the cooperative board for the year beginning July 1, 2017 through June 30, 2018 be approved in the amount of \$2,302,837?

Ms. Ritcheson moved, Ms. Parker seconded that the School Board be authorized to transfer up to \$922,000 from available fund balances to the Capital Reserve Fund and to expend up to \$1,031,708 from said Capital Reserve Fund to fund a portion of the total track and field project costs previously authorized by the voters, as well as to fund costs of maintenance of plant and remodeling under authority of 20-A MRSA \$4001?
